

The BSA MCC of NSW Inc

Rules for the use of Conditional Registered Vehicles

This scheme is a permit to use Conditional Registered Vehicles upon public streets subject to these rules which are in addition to The Motor Traffic Act and the RMS' Conditional Registration scheme. These rules apply only to vehicles where The BSA MCC of NSW Inc is nominated by the vehicle owner as the primary club.

1. **DEFINITIONS:** for the purpose of this document -

- a) **'Club'** shall refer to The BSA Motor Cycle Club of NSW Inc.
- b) **'In writing'** shall include communications in any form that result in a permanent record which may be kept by both sender and receiver.
- c) **'Event'** shall include Club meetings, scheduled rides, static displays or any other use of the vehicle deemed appropriate by the Club.
- d) **'RMS'** means the Roads and Maritime Services of New South Wales (formerly the Roads and Traffic Authority of New South Wales) or their subsequent body as determined by the Government of the day.
- e) **'Club Registrar'** means the person nominated by the Club to perform the duties set out in the Club's Constitution.

2. All vehicles and users must, at all times, comply with the provisions of the Motor Traffic Act, including the general provisions for use of Conditional Registered vehicles.

3. Members seeking inclusion in the Club's Conditional Registered permits scheme **MUST** -

- a) Be authorised to drive or ride a motor vehicle in the State of N.S.W.;
- b) Be a current financial member of the Club;
- d) Be resident in N.S.W. or the A.C.T.; and
- e) Obey all reasonable requests of the Club Registrar and the Club's machine examiner.

4. The motor vehicle(s) to be covered by this scheme **MUST** -

- a) Be at least of thirty years of age (such age shall be derived from the age designated by the youngest serial number on the vehicle);
- b) Be in a roadworthy state of repair;
- c) Be inspected by the Club's authorised machine examiner or by an RMS authorized inspection station licensed to issue roadworthy certificates for that class of vehicle; and
- d) Be assembled from components commensurate to the age and period of the vehicle and as near as practicable to standard, as determined by either the relevant model specialist or technical committee, whose decision is final.

5. Conditional Registered plates -

- a) Must be displayed with the registration label as prescribed by the RMS;
- b) Must be either renewed or returned to the RMS within three months of the expiry of the registration;
- c) Must be returned immediately to the RMS upon a person ceasing to be a member of the Club;
- d) Are **NOT TRANSFERABLE** and must not be included in the sale of a motor vehicle nor can they be displayed on any vehicle other than the one listed on the permit;
- e) Must be returned to the RMS within seven days of the sale of the motor vehicle and must not be transferred to another vehicle regardless of whether the same person owns the other vehicle or not; and
- f) Must not be defaced or altered.

6. The Conditional Registered vehicle may be used **WITHOUT** prior notice to the Club Registrar to -

- a) Attend any authorised Club event listed in the Club's newsletter or webpage;
- b) Attend other clubs events that the Club has been invited to in writing and accepted **In Writing** (see definitions);
- c) Travel to and from the events as listed in rule 6 a) or b) above; or
- d) Obtain fuel and oils, inflate tyres, service vehicle, test motor and other mechanical / electrical components and other such necessary trips, within a radius of sixteen (16) kilometres of the garaging address shown on the RMS registration certificate.

7. Prior notice to and the approval from the Club Registrar **MUST** be obtained to use a Conditional Registered vehicle:

- a) to obtain specialised services, parts or the like from places outside the sixteen (16) kilometre radius specified in rule 6 d) above. This includes obtaining the use of specialist tooling and/or assistance from fellow club members;
- b) To test the reliability and performance of electrical and/or mechanical components, verify fuel and/or oil consumption outside the sixteen (16) kilometre radius as specified in rule 6 d) above;
- c) For reasons of safety, escort a Club member who is using their vehicle in accordance with rule 7 a) or b); or
- d) To attend parades, displays and the like for charitable institutions to which the member, as an individual, has been invited by the charitable group in person.

8. The vehicle shall not be used for any other purpose.

9. A Conditional Registered vehicle must be used at least **twice** in any calendar year to attend an event covered in rule 6 parts a), b) or c) or the member's right to use Conditional Registration on that vehicle through the Club may be withdrawn and the RMS duly notified.

In such cases the vehicle concerned ceases to be registered as defined by the NSW Motor Traffic Act and the owner is committing a crime in using, or allowing the vehicle to be used, on a public street.

10. Members **MUST** keep a copy of these rules, including any subsequent amendments, the RMS Certificate of Approved Operations and a map showing the sixteen (16) kilometre radius specified in rule 6 d) above with them at all times that the vehicle is being used, and comply with the requirements stated in those documents.

11. An up to date register of the Conditional Registration Plates and their users and Day Book shall be kept by the Club Registrar and must be available for inspection by an appropriate officer of the RMS within reasonable time upon written request.

12. Club members seeking to be included in this scheme must read and sign the declaration on the bottom of these rules. The signature copy is to be kept by the Club Registrar.

13. Any breach of the above rules 1 thru 11, may result in the authorisation to use Conditional Registration through the Club being withdrawn and/or other penalties as determined by the Club's committee.

14. Inclusion in this scheme does not prevent the owner access to Conditional Registration through other clubs. Where the Club is nominated by the vehicle owner as the primary club, these rules shall apply at all times including participation in events under the jurisdiction of one of the secondary nominated clubs.

15. Where the Club is nominated as the primary club for a particular vehicle, no other club can also be nominated as the primary club for the period of the current registration. Should the owner wish to change the nominated primary club, the current issued Conditional Registration plates must be returned to the RMS and a fresh application submitted to the RMS.
